e) Rights to which personal data subjects are entitled under Article 11 of the Law no. 6698

requires an additional cost, please be advised that you will be asked to pay the fee in the fee tariff specified by the Board on Protection of Personal Data. In this respect, as the personal data object, you are entitled to:

- learn whether or not your personal data are being processed,
- request information if your personal data have been processed,
- learn the purpose of personal data processing and whether these data are being used for the indicated purpose,
- request information on third parties in Turkey or abroad to whom your personal data have been transferred,
- If your personal data have been processed deficiently or erroneously, request their correction and to request notification of the same to the third parties to whom your personal data have been transferred,
- request deletion or destruction of personal data if, though processed in accordance with the Law no. 6698 and other relevant laws, the reasons necessitating processing of the data no longer exist and to request notification of the same to the third parties to whom your personal data have been transferred,
- object to any negative result via analysis of the processed data via exclusively automatic systems, and
- request compensation of any damages you have sustained due to illegal processing of your personal data.
