Please kindly be advised that your personal data will be processed by Deutsche Bank A.Ş. ("Bank") within the context to be explained in this disclosure as the Data Controller, in accordance with the Law on Protection of Personal Data no. 6698.

First of all, we would like to explain our aim in processing your personal data; as the Bank, the personal data we have obtained are processed for the purposes of creating, processing and finalizing your complaints, provision of the services you have requested of us in the area of banking and capital markets, confirming the transactions conducted, identification of transaction details in case of any possible disputes or for audit purposes.

We would also like to brief you on with whom and for which purposes your personal data are being shared. Please note that personal data collected may be shared with our business partners, suppliers, shareholders, subsidiaries, relevant public authorities and private persons for the purposes of processing of your personal data for fulfillment of the aims described herein above within the context of the condi tions and purposes stipulated in Articles 8 and 9 of the Law on Protection of Personal Data no. 6698, provided that it is limited with the aims indicated in General Disclosure on Processing of Personal Data disclosed on www.db.com.tr.

We would also like to brief you on the collection method of and legal reason for collecting your personal data; your personal data are being collected by the Bank via different channels and based on different legal reasons; for the legal purpose of fulfillment of the legal and commercial liabilities of the Bank and the persons in business relationship with the Bank. Personal data collected are processed for the pur poses of creating, processing and finalizing your complaints and for provision of the services you have requested of us in the area of banking and fulfillment of our legal liabilities of provision of the services we offered.

Finally, we would like to provide you information on the rights you have as data subjects.

As personal data subjects, you have the right to

- learn whether or not your personal data are being processed,
- request information if your personal data have been processed,
- learn the purpose of personal data processing and whether these data are being used for the indicated purpose,
- request information on third parties in Turkey or abroad to whom your personal data have been transferred,
- If your personal data have been processed deficiently or erroneously, request their correction and to request

notification of the same to the third parties to whom your personal data have been transferred,

• request deletion or destruction of personal data if, though processed in accordance with the Law no. 6698 and other

relevant laws, the reasons necessitating processing of the data no longer exist and to request notification of the same to the third parties to whom your personal data have been transferred,

• object to any negative result via analysis of the processed data via exclusively automatic systems, and

• request compensation of any damages you have sustained due to illegal processing of your personal data.

Should you notify the Bank of your request regarding your rights via methods indicated in General Disclosure on Processing of Personal Data disclosed on www.db.com.tr, the Bank will finalize your request within the shortest time possible based on the characteristics of the request and in any way not later than thirty days free of charge. However, if the requested transaction requires an additional cost, please be advised that you will be asked to pay the fee in the fee tariff specified by the Board on Protection of Personal Data.
